The Artist Marketplace is a major fundraiser for the Brookline Arts Center to enable us to follow and improve upon our mission:

The Brookline Arts Center is a non-degree school for the visual arts committed to stimulating individual creative expression and appreciation of the visual arts by providing high quality, affordable programming. The Center is a supportive environment where people of all ages, backgrounds and abilities can study, create and present art. Through educational programs, community outreach and exhibitions, the Brookline Arts Center brings people together and enhances community life.

The Center is a non-profit organization for the visual arts founded in 1964. For 47 years the Center has maintained a serious commitment to the arts, artists, and community, offering year-round classes, workshops and programs for all ages, with a teaching staff of professional artists.

Artist Marketplace Information

In December 2011, the Brookline Arts Center will present for sale an eclectic mix of art, with a focus on regional artisans. A jury will select approximately 20-30 artists to exhibit.

The amount of work required from each artist is flexible, since the show is in a gallery style setting, rather than in individual booths. Our best selling price range is \$10-\$250.

Artists are not required to be present during the weeklong marketplace. The Brookline Arts Center is a two story, vintage 1886 converted fire station building. The Center is situated on the Brookline/Boston line close to Cambridge, Newton, and Chestnut Hill and is easily accessible by public transportation

Shipping/Drop off:

Shipped work (UPS/Fed Ex/etc.) will be accepted only for out-of-state artists and Massachusetts artists living beyond Route 495. Inventory should arrive between Monday, October 31–November 17, 2011, no earlier or later. Please Note: Local artists and Massachusetts artists living within Route 495 must hand deliver their work to the Arts Center on

Wednesday, November 9, 2011, and pick up any unsold work on Thursday, January 5, 2012.

Sales Commission:

The BAC will keep a 45% commission on all sales. Participating artist's checks will be mailed by January 31, 2012.

Application Deadline: postmarked by September 1, 2011

Application Requirements

- Five color photographs, color xeroxes, postcards, brochure images, or digital images representing work you plan to exhibit. **Digital images should be in TIFF or JPEG format and should be 300 DPI.** Mark each visual with your name (not business name) and an arrow indicating the top, and number them from 1 through 5 to correspond with the written description on the next page of this application. (If you are a returning artist, we ask you to provide images again because the jury is different each year, we like to see your current work, and we can also use many images for publicity.) Please Note: If you apply via e-mail the jury will not consider your application until the application fee has been received.
- A self-addressed stamped envelope (SASE) with two first class stamps for return of images. Images will be returned after the jurying of all artists. The Brookline Arts Center will not return CDs to artists who have been accepted.
- A \$10.00 non-refundable application fee. Make check or money order payable to: **Brookline Arts Center.** You may also pay with a Visa or Mastercard.
